

TERMS OF SERVICE

The regulations define the rules of use from the website <https://fobos.tech/>, hereinafter referred to as the Website.

By visiting this Website, you accept the provisions of the Regulations.

If you do not accept them, please leave the Website.

I. GENERAL INFORMATION ABOUT THE SERVICE

1. These regulations define the rules for using the website <https://fobos.tech/> run by FOBOS SPÓŁKA Z OGRANICZONĄ ODPOWIEDZIALNOŚCIĄ with its registered office in Warsaw, ul. Puławska 12/3, 02-566 Warsaw, entered into the National Register of Entrepreneurs maintained by the District Court for the Capital City of Warsaw in Warsaw, 14th Commercial Division of the National Register of Entrepreneurs under the KRS number 0001014805, NIP (Tax Identification Number) 1133083600, REGON (National Business Registry Number): 52424964000000, with the share capital of PLN 10,500, fully paid up, e-mail contact@fobos.tech
2. The words used in these regulations have the following meanings:
 - **User** – any natural person with full legal capacity who visits or browses the Website
 - **Service** – website available at <https://fobos.tech/>, which is the business card of the entrepreneur and information about the activities carried out by the Owner
 - **User Portal** – a separate tab of the Website, available only after logging in, which contains tools to support exposure therapy using VR technology
 - **Owner** – an entrepreneur running a business under the name FOBOS LIMITED LIABILITY COMPANY with its registered office in Warsaw, ul. Puławska 12/3, 02-566 Warsaw
 - **Statute** – these regulations, which define the rules for using the Website
3. All materials used to present the Website or published on this Website, such as photos, descriptions, content of articles in the Blog tab, trademarks or distinctive markings, logos, and other materials that constitute part of the Website, are the property of the Website Owner or third parties (including, in particular, the Owner's licensors and contractors) and are protected by law (applicable intellectual property laws, including copyright). Do not copy or use them for commercial purposes or to present these materials in any media without the Owner's prior express consent. You may use these materials within the scope of permitted use, to the extent and under the terms specified by applicable law.

II. USE OF THE SERVICE

1. In order for the User to be able to use the Website without interruptions, it is necessary to:
 - having technically efficient devices with Internet access;
 - meeting the minimum technical requirements by the operating system used by the User:
 - Having a current version of a web browser: Chrome 6.1, Safari 6.1, Firefox 5.6, Opera 4.7, Edge 4.1 or higher;
 - having a web browser that includes current updates with JavaScript enabled,
 - enabling cookies in your browser,
 - enabled support for the SSL (or TLS) secure data transmission protocol;
 - in some cases, the use of HTTPS may also be required;

2. Using the Website always involves some risk, e.g. exposure to malicious and unwanted software, *spyware*, *malware*, viruses, possibility of exposure to the so-called *cracking* and *phishing* (obtaining confidential information) or the so-called *sniffing* (interception of confidential information), and threats related to piracy. The Owner takes measures to minimize this risk, in particular by securing servers, connections, and the Website. However, it is not possible to completely eliminate risks. The Owner recommends using antivirus software or other measures to protect online identification.
3. It is prohibited to:
 - the User providing illegal, offensive, vulgar, hateful, false or misleading content,
 - taking actions that may violate the rights or property of other entities or make it difficult for other users to access the Website (including denial of service attacks),
 - transmitting or disseminating computer viruses, unsolicited or unauthorized advertising or any other form of "spam",
 - copying, accessing, modifying, multiplying, decompiling, disassembling, reverse engineering, extracting the source code of the Website,
 - compromising the integrity of the Website or its functioning.

III. CHANGES TO THE REGULATIONS

1. The Owner reserves the right to change the Regulations in the event of:
 - changes to the Owner's data;
 - changes in the Owner's scope of activity;
 - the Owner begins providing new services;
 - making technical modifications to the Website that require adapting the provisions of the Regulations to them;
 - legal obligation to make changes, including the obligation to adapt the Regulations to the current legal status.
